1. Street Team members under the age of 18 must submit proof of parental consent.
2. NRS reserves the right to refuse materials to anyone that we deem to be inappropriate for Street Team related work.
3. Street Team members will not engage in any illegal or inappropriate activity while performing Street Team activities.
4. Because Street Team activities may be conducted in dangerous or unsafe environments, members expressly and voluntarily assume the risk of death or personal injury sustained while participating in street team activities. Street Team members hereby release and discharge NRS from any and all liability, claims, demands, settlements, judgments or causes of action that arise out of participating in NRS street team activities.
5. Street Team members will not sue or make claim against NRS for damages or other losses sustained as a result of participation in street team activities. Street Team members also agree to indemnify and hold NRS harmless from all claims, judgments and costs, including but not limited to attorneys= fees, and to reimburse them for any expenses whatsoever incurred in connection with an action brought as a result of participation in Street Team activities.
6. Street Team members are not to speak with any media on behalf of NRS. All media inquiries should be directed to NRS' website whereby they can contact the appropriate NRS staff member.
7. Street Team members are not to accept donations of any kind on behalf of NRS. All those interested in making a donation to NRS should be directed to NRS website. If a street team member is interested in conducting a fundraiser, they should gain permission from NRS staff.
8. Street Team members are not to engage in any crisis related conversations with individuals they encounter through their street team efforts. All individuals in crisis should be directed to call NRS' 24 hour hotline, 1-800-RUNAWAY.
9. Street Team members should be polite and professional while handing out NRS materials or discussing the National Runaway Switchboard's services.
