The Green Light Project is a coordinated nationwide effort to illuminate buildings, spaces, monuments and bridges in green (the official color of Youth HOPE Month) as symbols of support and beacons of hope. The illuminations offer excellent visuals that can be shared on social media.

We encourage you to secure buildings and bridges in your community to be lit green in November. While there are usually no fees associated with turning a public building a specific color for a designated period of time, these requests often need to be made several months in advance.

Identify the contact person who handles the lighting program and submit your request (some buildings accept requests via a form on their website).
